# 11. Scientific planning

# a) Scientific strategy (MoU objectives, GP Goals, WG tasks and deliverables)

The Chair highlighted the forthcoming WG objectives, tasks, deliverables, as follows:

WG1, ML1.1 - Critical review and cost benefit analysis of different approaches implemented across Europe for AIM surveillance/monitoring, experimental design, data recording, statistical treatment of the results, spatial modelling mapping and identification of needs for harmonization and optimal exploitation (**Year 2-Trimester III; GP2**)



WG1, DL1.1 - Report/publication on sampling design for monitoring and surveillance of AIMs and EAIMBV in Europe, (Y3-I; GP3)

WG2, ML2.1- Systematic mapping of conventional and novel AIM control practices (Y2-II; GP2)

WG2, DL2.1 - Report/publication on conventional and novel AIM control practices in Europe (Y2-IV; GP3)

WG3, ML3.1 - Website functional (Y1-I; GP1) (achieved)

WG3, ML3.2 - Delphi and specialised questionnaires designed, tested and distributed **(Y1-IV; GP1)** (achieved with the distribution of questionnaires at AC conference plenary, on 14-02-2019)

WG3, DL3.1 - Web platform and science blog platform (Y1-II; GP1) (achieved)

WG3, DL3.2 - Report on results from Delphi and specialised questionnaires (Y2-I; GP2)

Progresses and plans for GP2 discussed during the WG-meetings were briefly summarized by the WGcoordinators (see minutes of WG-meetings). The Chair highlighted the need to identify possible delay ML/DL in order to request a postponement to COST, after appropriate motivations.

The Chair informed that the GP-2 expected budget would be 159,000€ and proposed a tentative budget plan for discussion, as follows.

# d) Dissemination planning (Publications and outreach activities)

-Results of the Questionnaires will be synthetized in a technical report for stakeholders (DL-3.2), and later in a scientific publication.

-WG would focus on discussing further dissemination and outreach activities in future months and propose an action plan for the 2<sup>nd</sup> AC at the latest.

-It was agreed to try to organize in GP3 or GP4, a special meeting for policy makers/national focal points (possibly co-organized with ECDC or WHO), possible as side meetings in EU ministry of Health or as a session on appropriate meeting.

-The need to acknowledge AIM-COST in future publications on AIMs was stressed.
